
**Sub: Scheme for promotion of Solar Water Heating System through Rebate/Incentive for Domestic Household consumers/ Non commercial Institutions like Housing Societies, NGO, Hostel.**

Sir,

In continuation to Department of Power letter No. F. 11(149)/2006-Power/P-III/ 83 & 1072 dated 12-01-07 & dated 30.04.2007 and letter no. F.1 (96)/2007-Power/2958 dated 03-12-07; I am directed to convey the cabinet decision no. 1879 dated 23/04/12, which is as follow:-


- i) Ex-post-facto approval for the scheme for Promotion of Solar Water Heating System through Rebate / Incentive for Domestic Household Consumers / Non Commercial Institutions during the year 2009-10, 2010-11 and 2011-12 with the similar conditions of release of subsidy as indicated in Cabinet Decision No. 1152 dated 18.12.2006 and Cabinet Decision No. 1309 dated 20.11.2007 which are as follows:-
  - a) Approval for providing lump sum incentive / rebate of Rs. 6000 to each domestic consumers only for installation of the Solar Water Heating System from the approved and authorized manufacturers/dealers either by way of availing loan from approved Banks/ Financial Institutions of Govt. of India or from its own finance to be given in one lump sum.
  - b) Approval for providing lump sum incentive of Rs. 6000/- per unit of 100 litres to Non Commercial Sector Institutions up to a maximum of 1000 Litres and maximum incentive up to Rs. 60000/- on the conditions that the incentive would be released directly to the Energy Saving Company installing the system and arranging to maintain it for 5 years as per commercial terms to be decided by the parties, certified by Third Party Inspection conducted by Energy Efficiency & Renewable Energy Management Centre, Department of Environment, Govt. of NCT of Delhi.

- c) The scheme is to be implemented through EE&REM Centre, Department of Environment, Govt. of Delhi i.e. the Nodal Agency notified by GNCTD for the purpose of Energy Conservation under the provisions of the Energy Conservation Act, 2001.
- d) Expenditure on the rebate/incentive will be provided to the Energy Conservation Fund from the Plan Fund
- (ii) Extension of the scheme for promotion of Solar Water Heating system through Rebate/incentive for Domestic Household Consumers/Non Commercial Institutions like housing Societies, NGO, Hostel etc. for the year 2012-13 with the similar amount and the same condition of release as indicated as in para (i) (a) to (d). The scheme may be reviewed after Financial Year 2012-13.
